Objective 1

• To ensure that at least 70% of abortions are done by MVA and MA and women receive CAC services in line with WHO recommendations and national evidence based standards.



(1.1) 1-2 Quarter 2015

- National standards on CAC based on the last WHO Guidance on abortion care elaborated and approved by MoH, but not created internet site.
- National standards are based on the most recent guidelines on abortion, the
 revision is planned for several years

(1.2) 3-4 Quarter 2015 year


Approved by the Ministry of Health and implemented training courses on CAC that is based on national standards.

(1.3) 3-4 Quarter 2015 year

Mifepristone, Misoprostol and MVA are included in the evaluation criteria of the balance score cards of the Results Based Financing project. In checklists of essential drugs.

(1.5) 3-4 Quarter 2015 year

Annual national medical statistical reports include new indicators on the numbers, quality and methods of abortion. The private clinic RHA held internal and external audit of the quality of services provided by CAC in Alliance clinics (Bishkek, Karakol) and partner clinics.



(1.6) 3-4 Quarter 2015 year

 At 1st of July 2015 held a regular meeting of the Coalition on Safe Abortion in Kyrgyzstan. In coalition work participated representatives of MoH, members from department of disease prevention and Sanitary Inspection, International organizations, nongovernmental organizations, working in the field of SRH, AIDS service organizations, health professionals and decision-makers in the field of health care in the primary and secondary levels. The main purpose of the meeting was to discuss the main achievements and challenges for the promotion of quality services for safe abortion in Kyrgyzstan at the level of public and private clinics, to discuss policies that affect people's access to information services in the field of prevention of unwanted pregnancies.

Following the discussion, the meeting participants stressed the need to discuss and review:

1- approaches to infection control; syringes and cannulas of MVA are reusable tools as recommended by WHO and the manufacturer (IPAS), disinfection and sterilization of medical devices must be carried out, as well as reusable instruments.

- 2 Clinical protocol on MVA approved by the Ministry of Health in 2014, with amendments and additions;
- 3 price list for abortion services in health facilities;
- 4 prescription of drugs Mifepristone and Misoprostol in pharmacies by prescription system;
- 5 integration of training modules on the SRH and Safety Abortion in pre- and post- graduate training in educational institutions.

(1.7) 1-4 Quarter 2016 year

- Conducted 1 training course for 30 employees in Bishkek at March 2016, with the support of pharmaceutical company «Stada Pharm».
- Kyrgyz alliance of family planning conducted 5 day trainings with the participation of assistants from Institute of postgraduate study to south district specialists, monitoring visits and statistical reports.


(1.9) 4 Quarter 2015 year, 1-4 Quarter 2016 y.

• 70% of women of reproductive age should get an MVA or MA service.

During 2015 in the Kyrgyz Republic, the termination of pregnancy up to 12 weeks is 12163. From MVA 8151, MA 3246, curettage method 766.

Objective 2

To ensure that CAC services are offered by authorized midwifes and family doctors in at least 50% of raions (districts) with insufficient number of obstetricians-gynecologists



(2.1,2.2,2.3) 1-2 Quarter 2015 year

- Were trained 28 midwives. Of these, 14 in Jalal
 - Abad oblast, 14 in Chui Oblast.
- Available drugs for medical workers with a certificate. Preparations are available in pharmaceutical company "Stada Pharm", "Plasma".
- Monitoring QoC of CAC services offered by family doctors and midwifes in two pilot rural districts and publish a report.

(2.4,2.5) 1-2 Quarter 2016 year

- The report studies on the use of midwives pharmaceutical abortion discussed at the end of April 2016. 502 abortion was done by midwives.
- Develop and adopt by the MoH (act) about the possibility of abortion services by family doctors and midwives is in progress.
